






2021 TA Forum Main Stage v1


Residential Program Trends 2018 - 2020




Residential Project Installation Trends 2018 – YTD 2021




Ceiling Insulation Bonus

Incentive Changes

• Central Air Conditioning - Now two incentive tiers

Ductless Heat Pump Cost Effectiveness Exception Request

 Requested cost effectiveness exception from OPUC for ductless heat pumps installed in homes to replace zonal electric heat

2022 Home Retrofit Incentive Changes: Central AC

Upgrade	Changes to Requirements	2021 Incentive	2022 Incentive
Central Air Conditioning (SEER 15, EER 12)	Minimum system Seasonal Energy Efficiency Rating (SEER) of 15, and a minimum system Energy Efficiency Rating (EER) of 12 or greater	\$250	\$100
Central Air Conditioning (SEER 16+, EER 12)	Minimum system Seasonal Energy Efficiency Rating (SEER) of 16 or greater and a minimum system Energy Efficiency Rating (EER) of 12 or greater	N/A	\$250

2022 Existing Multifamily Incentive Changes

Measure	Details	2021 Incentive	2022 Incentive
Commercial Condensing Tankless Water Heater >200 kBtu	Discontinued for Existing Multifamily in Oregon starting 2022	\$1.50 per kBtuh	\$1.50 per kBtuh in WA only
Hydronic Heating Circulator Pumps	No change in requirements	speed; \$150-\$750 for variable	\$200-\$300 for single speed; \$300-\$750 for variable speed
Multifamily Steam Traps	Must replace a failed, open existing steam trap; repairs no longer eligible	\$100 per trap	\$100 per trap
Residential Gas Storage Water Heater	No change in requirements	\$150 per unit	\$100 per unit
Central AC	Requirement and incentive tier change	\$250 for 15 SEER	\$100 for 15 SEER; \$250 for 16 SEER

Commercial Dishwashers	Some types of dishwashers will no longer be cost-effective and will sunset at year end	Varies	\$900 for all remaining types
